If Applicant's offer to rent is not accepted upon receipt of the above-described funds. Landlord will notify Applicant either in writing or verbally if the offer to rent is not accepted and shall refund the funds (excluding the application fees), as specified above.

If Applicant's offer to rent is accepted, but the premises do not become available on the agreed date, then Landlord will refund the entire amount paid by Applicant.

If Applicant no longer wants a space from Kasa Properties, the above funds are **not** refunded. If, after acceptance, Applicant fails to enter into the agreed Rental Agreement and pay the balance of either the first month's rent or security deposit, the Landlord may deduct from the amount received an amount equal to 1/30th of the above monthly rent for each day the premises are vacant from the date Applicant's tenancy was to begin, to date tenancy commences upon re-letting, not to exceed 30 days.

Landlord, within twenty-one (21) days after the premises are re-let, shall return to Applicant, to the Applicant's address shown below, any balance remaining, with an itemization of Landlord's damages.

If any legal action or proceeding is brought by either party to enforce any part of this Agreement, the prevailing party shall recover, in addition to all other relief, reasonable attorney's fees and costs.
